## 2. STATUS OF NATIONAL ACTION PROGRAMME

The development of the National Action Programme to Combat Land Degradation (NAP) was completed in 2006, after review and incorporation of stakeholder's comments and has been approved by the Cabinet. The Ministry of Planning, Housing and the Environment (MPHE) is in the process of formally establishing the National Coordinating Committee which will include members of the Interim Coordinating Committee and other representatives from other government and non-government institutions as proposed in the NAP. Some of the projects included under the programme are already underway. Information on the status of the NAP process is provided below:

NAP has been integrated into the Poverty Reduction Strategy/Plan (PRSP)	No. There is no formal National Poverty Reduction Strategy in Trinidad and Tobago. However, there is a Poverty Reduction Unit housed in the Ministry of Social Development which undertakes the implementation of poverty reduction measures. Currently, the Unit is conducting a comprehensive assessment of poverty in Trinidad and Tobago, which will enable Poverty Reduction Recommendations/Plans to be developed which can form the basis for the preparation of a PRS/P. The MPHE proposes to hold discussions with the Poverty Reduction Unit on integration of the NAP into their work programme.
NAP has been integrated into the National Development Strategy (NDS)	The Vision 2020 Secretariat established in 2003 to oversee the preparation and implementation of the NDS and the draft Vision 2020 NDS was completed and adopted in 2005. During the development of the NAP, members of the Vision 2020 Secretariat were actively engaged in the consultation process. Discussions will be held with the Secretariat on the integration of the NAP into the NDS process.

## 7. THE CONSULTATIVE PROCESS

There is no information on the partnership agreements initiated within the framework of the UNCCD involving collaboration between Trinidad and Tobago and other parties.

The Interim NAPCC supervised the preparation of the NAP and elaborated a process for public participation. As such, apart from meetings held with individuals from public sector, private sector agencies and members of the NGO community, a series of meetings was held during the preparation, review, and finalisation of the NAP.

Additional meetings were held also with the UNCCD Secretariat and the Interim NAPCC in December 2006 to discuss the implementation of the NAP. Table 7(b) provides a list of consultative meetings on UNCCD implementation.
